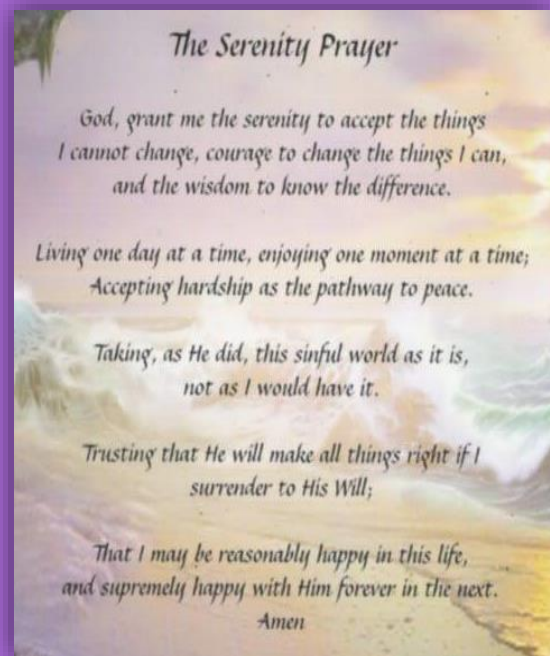

***** FEMA ANNOUNCEMENT *****

HUNT VALLEY, Md. (SBG) - The Federal Emergency Management Agency will soon begin reimbursing Americans for funeral expenses of family members who passed away due to COVID-19.

Congress passed the \$2 billion funding in December as part of a \$900 billion stimulus bill. The funding was promoted by Senator Majority Leader Chuck Schumer and Rep. Alexandria Ocasio-Cortez, D-N.Y., and \$260 million will be allocated to their home state of New York, which was hit hard by the pandemic last year. The two representatives want to keep the program in place for the rest of the pandemic.

Families can be reimbursed up to \$7,000 for funeral expenses, retroactive to Jan. 20, 2020. Those who apply will need to submit identifying documentation of the person who died, as well as a death certificate. According to the National Funeral Directors Association <<https://nfda.org/news/statistics>>, the national median cost for a funeral in 2019, including viewing and burial, was \$7,640.

Ocasio-Cortez said her family struggled with funeral funds for her father when she was 18 years old, saying the expenses "haunted and followed my family, along with many other families in a similar position, for years."

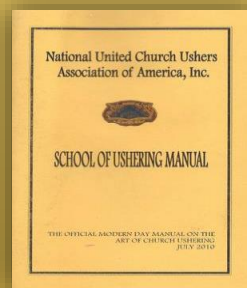

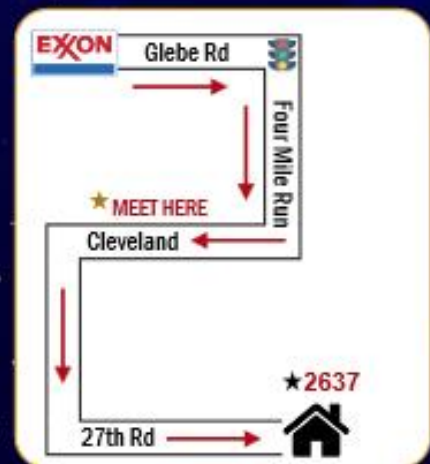

J. W. Abernathy Scholarship Guidelines

John W. Abernathy was a member of the Ebenezer Baptist Church in Alexandria, Virginia. He was a junior usher, an active member of the ICUA of VA, Inc. Usher's Chorus, and a basketball player. John died unexpectedly of a heart attack. The John W. Abernathy Scholarship of Virginia was established in January 1984 in his memory.

The purpose of the John W. Abernathy Scholarship is to provide financial assistance to eligible Junior and Young Adults ushers who are pursuing post high school educational opportunities. Awards will be determined based on the selection criteria identified below, the number of applicants and availability of funds.

WHO IS ELIGIBLE

1. Any junior or young adult usher who is a member of an usher ministry whose senior usher ministry is a member in good financial standing with the ICUA of Virginia, Inc.
2. Any junior or young adult usher that is a senior in high school or in the first or second year of college, who has served in their local ministry for at least two (2) years.

CRITERIA FOR THE SCHOLARSHIP

Each applicant must:

1. Complete and submit the application form.
2. Present three letters of recommendation (a) one from a teacher, counselor or principal, and (b) one from someone in the community.
3. Must have maintained a 2.5 grade average or higher for two quarters before applying for the scholarship
4. Must participate in church activities.
5. Plan to pursue education above the high school level (computers, business, a trade or college).
